We note that the Monitoring Framework has not been made available for public consultation – see FFC 89 of FFC public consultation document and the following 'note' regarding the FFC:

Further Focussed Change: FFC89 Section: 5. The LDP's Monitoring Framework

Reason:

 To relocate the Monitoring framework from Appendix 3 into the main body of the LDP's written statement as Section 5, in accordance with the Inspector's letter to the Council dated 6/5/2016.

NOTE: The proposed changes to the monitoring framework set out below consist of proposed further focussed changes to Core and Core Output Indicators only. Further work is being undertaken on changes to proposed Local Indicators to inform the Examination and will be made available in due course.

This Local Development Plan is therefore not in a state either to go the Inspector or to be put out for

consultation. It is an incomplete document. Worse than that, there are two *different* incomplete LDP FFC documents, one of which has been presented to cabinet and approved by the Council for consultation and a second, different document which has been put out for consultation but not approved by the cabinet. Which document is to go to the Inspector? One without Powys Cabinet approval or one which has not been publicly consulted?

We do not understand how valid public consultation can take place without all relevant documents which will make up the Local Development Plan being made available for public scrutiny. It appears that the consultation exercise which has taken place over the period 10th October to 21st November cannot have legal validity.

We are aware that some work *had* been done on the LDP Monitoring Framework prior to the Cabinet meeting of 13th September 2016, although Cabinet were also told that this work had not been completed. Further Focussed Change: FFC89 Section: 5. The LDP's Monitoring Framework

Reason:

- To relocate the Monitoring framework from Appendix 3 into the main body of the LDP's written statement as Section 5, in accordance with the Inspector's letter to the Council dated 6/5/2016.
- NOTE: The monitoring framework has not been updated or amended for the further focussed changes. Further work will be undertaken on the monitoring framework to inform the examination in due course.

In particular one addition which must have been made very shortly prior to the Cabinet meeting is the inclusion of 'Sustainable Energy: Renewable and Low Carbon Energy – AMR 33' with its substantial target for renewable generation within the county.

We question why the Cabinet felt it was appropriate or acceptable to give their approval to an important legal document which they had not seen in complete form, and for which they will be held accountable. We question also what advice was given to cabinet by the Report Author and Portfolio Holder, Avril York, as to the state of completion of the Schedule of Further Focussed Changes.

Schedule of Further Focussed Changes as presented for public consultation make no mention of the AMR 33, even though it is stated that the information presented contains the general changes to the Monitoring Framework and 'Specific changes to individual Core and Core Output Indicators'.

We had serious concerns about the adequacy and appropriateness of the monitoring measures put out in earlier drafts of the LDP. We observed, for example, in commenting on focussed changes that some monitoring data had no relevance to the objective to which the monitored policy related. We will not comment on individual AMRs as this monitoring section is incomplete and must be put out for consultation again. However, we do not see much here, or in the monitoring section of the LDP FFC which was put to cabinet, to suggest that this section has yet been much improved. Accordingly we attach as appendices our previous Focussed Changes representation on monitoring and hope that the comments within will feed into the revised document.

Clearly in the state it's in the Monitoring section of the LDP FFC is not ready for consultation. It not only fails to give the complete picture but it fails to mention the single most important change that has been made within the Further Focussed Changes.

Major procedural errors:

- 1. Presentation to and approval by Cabinet of incomplete documents
- 2. Public consultation of incomplete documents
- **3.** No documents fit for submission to Inspector as either *incomplete and unapproved*, or *incomplete and unconsulted*.
